Effective June 1, 2020, to sell Century Systems Inc.'s products, any advertised prices outside of your physical location(s) cannot be more than 15% below our stated MSRP except for Miracle Lotion® which cannot be below \$18.00. This includes the internet and any advertising or promotion that is encountered outside of your physical location(s). Please read full details below:

MAPP Introduction

At Century Systems Inc. (hereinafter, "Century Systems", "Century" or "CSI") we have determined that advertising Century's products at prices below certain levels undermines our reputation and brand and discourages Century's retailers from investing in the growth of Century's product lines, generating a sustainable profit margin for retailers and providing the best possible service and support to consumers. We are aware of the time and resources many of you invest to create an excellent customer experience. We want to protect your ability to do so, while simultaneously discouraging price-based advertising that could become detrimental to your service and support efforts, and to Century Systems' competitive position. Therefore, Century Systems has adopted this Minimum Advertised Price ("MAPP") policy, which applies to all Advertisements (as defined below) of Century Systems products by all distributors, retailers, dealers and other retailers of Century Systems products (hereinafter, "Retailers"). As a condition of being an Internet Reseller of Century Systems products, it is essential that you adhere to the following terms and conditions. Failure to abide by these terms and conditions may result in the suspension and/or termination of your account with Century Systems. This policy is provided to all new and existing customers as a benefit of being a valued customer of CSI.

Terms and Conditions

1. Effective June 1, 2020, to sell CSI products any advertised prices outside of your physical location(s) cannot be more than 15% below our stated MSRP except for Miracle Lotion® which cannot be below \$18.00. This includes the internet and any advertising or promotion that is encountered outside of your physical location(s).
2. CSI establishes a Minimum Advertised Pricing Policy (MAPP) for its products. MAPP may be adjusted by CSI at its sole discretion. Such adjustments shall be uniformly applied to all CSI dealers and resellers in the United States.
3. The MAPP applies to the price at which CSI products are offered for sale to a consumer from the Internet Reseller. Final sales price remains totally at Internet Reseller's discretion within the agreed Minimum Advertised Price Policy to be anywhere between MSRP and a maximum of fifteen (15) % off MSRP with the exception of Miracle Lotion®. No further discounts or coupons can be applied to CSI products. The Internet Reseller understands that a violation of this policy is grounds for termination of the Internet Reseller relationship with CSI.
4. An advertisement includes any and all promotional or pricing information accessible to consumers via any type of media, marketing, or promotional materials, including, without limitation:

- Flyers, posters, coupons, mailers, inserts, newspapers, magazines, catalogs, mail order catalogues, internet or similar electronic media including web sites, email and email solicitations, newsletters, television, radio, public signage, trade shows, billboards; and
- All forms of Internet advertising, including, without limitation, all websites and website pages and banners, social media, emails, blogs, portal sites, and search engines (including but not limited to Google, Google Shopping, Yahoo, etc.) whether or not products are sold from those sites. This includes prices listed in emails, search engines or placement of ads on any other website, including natural or paid search engine listings, shopping sites, marketplaces and auction sites. Internet sites that ask customers to utilize their shopping cart as a way of displaying pricing are in violation of this Policy. At no time may the Retailer make any statement on its website or other sites in connection with any product that indicates or implies that a lower price may be found at the online checkout stage. Moreover, using another company's website to display a lower price than the MAP and offering a link to your website or to display a lower price than MAP is prohibited.

Violations

Century Systems will monitor and review Retailers' advertisements for violations of this Policy. Violations of the Policy shall be determined by Century Systems in its sole discretion. Retailers have no right to enforce the Policy and Century Systems will not communicate with any Retailer or third-party regarding violations of this Policy by others. Century Systems reserves the right to impose the following if Century Systems believes that:

- i. A Retailer has violated the provisions of this Policy; or
- ii. A Retailer has engaged in any activity that Century Systems determines, in its sole discretion, is designed or intended to circumvent the intent of this Policy.

Specifically, If CSI determines that an Internet reseller is in violation of its MAPP policy, CSI reserves the right to cancel any pending orders, restrict future orders, suspend discounts, or immediately revoke the authorization to purchase any of the company's products for a period of at least one (1) year but potentially indefinitely. CSI's MAPP Administration is solely responsible for determining whether a violation has taken place, as well as determining the appropriate sanctions which are as follows:

First Violation: Warning only. Request to abide by Policy within 24 hours. No action taken.

Second Violation: Block Retailer's account for 30 days after sending notice of the violation.

Third Violation: Cease doing business with Retailer.

However, CSI reserves the right to not provide prior notice before taking action under this Policy.

This Policy does not constitute an agreement between any Retailer or other party and Century Systems. Century Systems is not seeking, and will not accept, any agreement or other assurance of compliance from any Retailer or other party to adhere to this MAP Policy. It is entirely within the discretion of the Retailer whether to comply or not comply. This Policy is non-negotiable and will not be modified for any Retailer. The Policy is not intended to control, influence, determine, limit, or affect in any way the actual prices at which Retailers ultimately sell Century Systems products to its consumers in their physical stores. The Policy is strictly limited to restrictions on advertised prices outside of Retailer's physical location(s). Each Retailer remains free to determine its own resale price for Century Systems products within their physical location(s).
